ML530: LIFE LONG DEVELOPMENT (4 units)

DESCRIPTION:

This course explores the nature of Christian leadership development based on J. Robert Clinton's *Leadership Emergence Theory*. Emphasis in this course is upon recognition of values and lessons learned as God shapes a leader over a lifetime. Many individual concepts flowing from these variables such as process items, unique timeline, response patterns, giftedness development, and others are examined, all with a view toward understanding one's unique shaping. The course aims to provide perspectives that aid lifelong development.

COURSE FORMAT:

The class will be conducted on the Internet using a 10-week lesson program aligned with Fuller's academic calendar. Each week students and the instructor will interact with the material through journaling, threaded discussions and live Internet "chats". The sessions include a time of spiritual formation and question/answer times, as well as further input on life-long development concepts. There will also be small group activities to apply the concepts.

LEARNING OUTCOMES: By the end of this course, students will have:

1. Gained key insights into how God has been shaping their life over a lifetime for unique purposes.
2. Become familiar with numerous *Leadership Emergence* concepts that are applicable to their own life and the lives of those they influence.
3. Constructed a *Personal Case Study* using course concepts including a unique timeline with its developmental life stages, giftedness development, and sense of destiny.
